New England Woodcraft's merchandise is warrantied to be free from defects in material and workmanship for a period of **five years** from the date of delivery. Our solid wood merchandise has an extended warranty of **ten years** from date of delivery to be free from defects in material and workmanship. New England Woodcraft's warranty does not apply to goods damaged in transit or abuse caused by the product user. In the event of a warranty claim, our sole liability shall be the repair or replacement of parts, necessary adjustments and other repairs required to maintain the product in proper working order. Manufacturers of upholstery fabrics do not guarantee their materials for wearing quality or color fastness, so we are unable to guarantee the fabric or fill materials for our upholstered goods. Due to natural wood variations, wood furniture is sold subject to minor variations or irregularities of color, surface grain, or texture.

Furniture is shipped at the purchaser's own risk after it has been carefully inspected and packed. It is accepted as such by the carrier, recipient should inspect it carefully. Any loss or damage should be noted on delivery receipt and claims filed immediately with the carrier. All other adjustments will be considered only if filed with us in writing within five (5) days after arrival of shipment. Merchandise will not be accepted for return unless previously approved by us in writing. Prices do not include packaging, crating, uncrating, storage, installation, or sales taxes.

However, New England Woodcraft does not adopt and does not guarantee or represent that the manufacturer will comply with any of the terms of the warranty of such manufacturer.

If the customer is unwilling or unable to accept delivery when the order is ready for shipment, we reserve the right to invoice as of the said date and store the furniture at the customer's risk and expense.

Orders can be cancelled up to the time raw materials are ordered. A \$1000.00 cancellation fee will be charged. Due to the fact that our furniture is produced when ordered, we cannot accept returns for reasons other than warranty claims.

**FURNITURE - GENERAL QUALITY CONSTRUCTION FOR CASEGOODS**

1. **SOLID WOOD:** Lumber shall be kiln dried, plain sawn Red Oak, Northern Hard Maple, Cherry, or Birch. Laminations consist of planks no less than 3/4 inch, no more than 4 inches in width. No splices, loose knots, torn grain, checks, snakes, splits, cracks or defects of any kind shall be permitted. LAMINATION: Planks shall be edge-glued using Franklin Titebond regular or imperial aliphatic resin glue. The glue joint shall be stronger than the wood itself. Moisture content at time of assembly shall be kept between 5% and 7% inclusive. All joints shall be true and tight and securely glued in place. Surface of joints must fit accurately with no openings or splintering. Joints shall have 100% glue coverage. No starved joints will be allowed. Excess glue shall be neatly and thoroughly cleaned from all surfaces exposed to view.

2. **PLYWOOD VENEER PANELS:** Full veneers are selected plain-sliced natural wood veneers. Composition boards utilized: Particle board Specification ANSI A208. 1 - 1979. Hardboard-product standard P558-73. Chipcore 42 lbs density TFI Manufacturing specification. Fiberboard ANSI A208.2-1980 3/8" – 48 lbs density. Hardwood Plywood US Department of Commerce Standard PS-51 -71. Type II.

3. **HIGH PRESSURE PLASTIC LAMINATE:** Plastic Laminate shall be a minimum of .02 with a typical thickness of .031 laid up on our industrial grade particle board. Plastic Laminate is also available laid up on veneer core plywood. Color to be selected from manufacturer's standard high pressure plastic laminate colors.

4. **DRAWER CONSTRUCTION:** On all drawer sides we use a 7/16" thick 5 ply finished hardwood veneer plywood. The drawer bottoms are made from 1/4" thick hardboard. All drawers are assembled with old-fashioned finger dovetail joints which is still the best drawer construction today. The drawers run on side-mounted heavy duty metal tracking with 75 lb test load capacity and come with drawer stops. The drawer fronts can be changed so they can be removed easily if one gets damaged. (See General Construction Features).

5. **INTERNAL CONSTRUCTION:** The interior framing inside the furniture items consists of a 4 sided hardwood frame at every drawer level. Each frame is lap jointed, glued and then stapled in all four corners. Each frame is then screwed to the interior cabinet sides. The base and top are also screwed to the interior framing of the cabinet. This type of frame construction allows one to change a side or top panel if the piece is damaged. All cabinets have reinforcing corner blocks glued and screwed into the corner of the base. (See General Construction Features).

6. **FINISHING:** Finish materials are of the best quality to give a hard, durable, smooth liquid resistant finish. All surfaces exposed to view in normal use are smoothly machined and sanded. The application of our finishing materials is controlled to produce items of a uniform, smooth quality appearance. Finishes are UV cured urethane and/or water base acrylic. *Our finishing process is environmentally friendly and emits no V.O.C.'s (Volatile Organic Compounds) into the atmosphere.* There is a 10% upcharge for staining – add suffix (STA).

**\*NOTE:** Our construction methods allow us to build to your specifications. Variations in dimensions, styles, and stain colors are all possible. Approved deviations from standard sizes will be offered at no additional cost to the customer.
